That a reasonable fee of \$7.50 each should be allowed to McKenzie-Nall Company, Clint Burdick and Lloyd Phillips, Appraisers, as compensation for their services;

That a reasonable fee of \$10.00 each should be allowed to Albert Biale, Ed Leutzinger and Willis DePaoli, Appraisers, as compensation for their services;

That Gregory J. Chachas, as Attorney for said estate and for the Administratrix, has advanced court costs in the sum of Fifteen and 60/100 Dollars (\$15.60) for which he should be reimbursed;

That Gregory J. Chachas, as Attorney for said estate and for the Administratrix, has received no compensation for his services rendered therein and should be allowed a reasonable fee therefor in the amount of One Hundred Fifty Dollars (\$150.00);

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the sum of Ten Dollars (\$10.00) each be paid to Albert Biale, Ed Leutzinger and Willis DePaoli, Appraisers.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that GREGORY J. CHACHAS be reimbursed the costs of administration advanced by him in the amount of Fifteen and 60/100 Dollars (\$15.60).

IT IS FURTHER ORDERED ADJUDGED AND DECREED that GREGORY J. CHACHAS be paid the sum of One Hundred Fifty Dollars (\$150.00) for legal services rendered the estate.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the sum of One Hundred Eighty-one & 90/100 Dollars (\$181.90) remaining be paid to and among the creditors of said deceased proportionately, according to the amount due them on their respective claims so as aforesaid established that is to say, the following sums shall be paid:
