ORDER SETTTLING FIRST AND FINAL ACCOUNT
AND DECREE OF DISTRIBUTION

ANNA MAE GILLIS, as Administratrix, having on the 31st day of May, 1966, filed in this Court her First and Final Account and Report of Administratrix and Petition for Decree of Distribution; said matter coming on regularly to be heard on the 13th day of June, 1966, notice of hearing of said Petition having been given in the manner provided by law, and at said time and place said Administratrix being represented in Court by her Attorney, GREGORY J. CHACHAS, and the Court hearing evidence adduced on behalf of said Account and Petition for Distribution, and it appearing to the satisfaction of the Court that due and legal notice of the hearing of First and Final Account and Report of Administratrix and Petition for Decree of Distribution was given in the manner and form as required by law, and that the residue of said estate, consisting of the property hereinafter described, is now ready for distribution, and said estate is now ready to be closed;

That the said MICHAEL JOSEPH GILLIS, aka MIKE GILLIS, died intestate on or about the 18th day of July, 1965, in the State of Nevada, being at the time of his death a resident of the County of Eureka, State of Nevada, and that said Decedent left estate in the State of Nevada consisting of real and personal property;

That ANNA MAE GILLIS was appointed and qualified as Administratrix herein on the 10th day of August, 1965, and Letters of Administration were duly issued to her on the 10th day of August, 1965;

That due Notice to Creditors was given as required by law and there are the following creditors' claims:

That ANNA MAE GILLIS, the surviving wife of the above-named Decedent, is the sole and only person entitled to the assets of said estate.

That the said ANNA MAE GILLIS, as Administratrix herein, has received no compensation for her services rendered to the estate and should be given the real property in said estate as compensation therefor;

That a reasonable fee of \$7. 50 each should be allowed to McKenzie-Nail Company, Clint Burdick and Lloyd Phillips, Appraisers, as compensation for their services;

That a reasonable fee of \$10. 00 each should be allowed to Albert Biale, Ed Leutzinger and Willis DePaoli, Appraisers, as compensation for their services;

That Gregory J. Chachas, as Attorney for said estate and for the Administratrix, has advanced court costs in the sum of Fifteen and 60/100 Dollars (\$15. 60) for which he should be reimbursed;

That Gregory J. Chachas, as Attorney for said estate and for the Administratrix, has received no compensation for his services rendered therein and should be allowed a reasonable fee therefor in the amount of One Hundred Fifty Dollars (\$150. 00);

That there remains for distribution to those entitled to the same, the sum of Four Hundred and no/100* * * * * Dollars (\$400. 00), and that said sum is insufficient to pay and discharge the said debts and claims so ascertained as aforesaid in full.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the said First and Final Account and Petition for Distribution is approved, allowed and settled.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that

the partial ownership in real property be given to ANNA MAE GILLIS, the Administratrix, as compensation for services rendered in said estate.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the sum of Seven and 50/100 Dollars (\$7. 50) each be paid to McKenzie-Nall Company, Clint Burdick and Lloyd Phillips, Appraisers.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the sum of Ten Dollars (\$10. 00) each be paid to Albert Biale, Ed Leutzingier and Willis DePaoli, Appraisers.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that GREGORY J. CHACHAS be reimbursed the costs of administration advanced by him in the amount of Fifteen and 60/100 Dollars (\$15. 60).

IT IS FURTHER ORDERED ADJUDGED AND DECREED that GREGORY J. CHACHAS be paid the sum of One Hundred Fifty Dollars (\$150. 00) for legal services rendered the estate.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the sum of One Hundred Eighty-one & ⁹⁰/₁₀₀ Dollars (\$181. 90) remaining be paid to and among the creditors of said deceased proportionately, according to the amount due them on their respective claims so as aforesaid established that is to say, the following sums shall be paid:
