

Certificate of Location

This Is to Certify, That a mining claim named the FERRIC HILL
 was located by
Blaine C Hoalst and Don Vaughn

on the 30th day of June 1966, situated in
unknown mining District, Eureka County, State of
Nevada, and about South and Southwest of Buckhorn old power line Apprx. 3000'
South of the Crescent Valley Spa Apprx. 1/2 mile South Near the line dividing Section
One and 12 Twp 29N, Range 48 E Crescent Valley Quad. Laying on the East side of the
hot springs hill above the valley floor.

We claim 1500 linear feet along the course of
 mineral bearing ledge, lode or vein, extending 750 feet from the
 location monument in a Southerly direction, and 750
 feet in a Northerly direction, together with 300 feet
 on each side of the center of the ledge for the entire length of the claim.

The discovery work consists of Several cuts at the location monument and
extending to the North along and crosscutting the lode. for a distance of apprx 160'
situated about 10-1508 feet in a (Shaft, cut or tunnel)
direction from the location
monument and its dimensions are 4 feet wide, 4 feet high,
6 feet long and 3 feet deep, exposing ledge, lode or vein in place.
and several small cuts aggregating 50 cubic feet

The northwest corner is marked by a 4"X4"X5' Red top Post feet high, inscribed
"N. W. corner Ferric Hill Mine"; the southwest corner is marked by a
4"X4"X5' Red Top Post feet high, inscribed "S. W. corner Ferric Hill
Mine"; the southeast corner is marked by a 4"X4"X5' Red top Post feet high,
 inscribed "S. E. corner Ferric Hill Mine"; the northeast corner is
 marked by a 4"X4"X5' Red top Post feet high, inscribed "N. E. corner
Ferric Hill Mine." There is also a 4"X4"X5' Post (One at West red top
 at
 the center of each side line. The discovery work has been done and the location completed
 since July 5th 1966
