LABORER'S LIEN

NOTICE IS HEREBY GIVEN, that JACK ESPOSITO, claims a lien for labor performed upon those certain unpatented mining claims situated in the County of Eureka, State of Nevada, and particularly described as follows, to-wit:

All those certain claims situate in the Mining District of Beowawe, situate in the said State, described as follows: Family Holding No. 1, No. 2, No. 3, No. 4, and No. 5.

That the names of the owners of said mining claims are NEVADA WESTERN MINING CO., a Nevada Corporation, as lessee from J. S. PAYNE and OLIVE A PAYNE, of Box 805, Winnemucca, Nevada, and that the resident agent of the aforementioned corporation is LES FERRELL of 1355 10th Street, Sparks, Nevada, and that the President of the aforementioned corporation is BENJAMIN GASSAWAY of Portland, Oregon.

That the labor was performed at the instance and request of LES FERRELL and BENJAMIN GASSAWAY.

That your Affiant was employed by MESSRS. FERRELL and GASSAWAY in the months of June, July, August, and September of 1966, and that the work was completed on the 19th day of September, 1966. That the work performed by your Affiant, and completed, was the operation of a bulldozer for the purpose of excavating and removing overburden on the aforementioned claims, claim surveying, staking, and development.

That the total wages owing at the agreed hourly wage rate amounted to the sum of TWO THOUSAND ONE HUNDRED FIFTY DOLLARS AND NO ONE-HUNDREDTHS (\$2150.00), and except for the sum of FIVE HUNDRED DOLLARS AND NO ONE-HUNDREDTHS (\$500.00), said wages remain unpaid, and that your Affiant claims a lien against the aforementioned mining property in the amount of ONE THOUSAND SIX HUNDRED FIFTY DOLLARS AND NO ONE-HUNDREDTHS (\$1650.00).

That more than 10 days have elapsed since the work was completed but not more than 90 days have elapsed since the date of completion.
