

LOCATION CERTIFICATE

This is to certify that the RIO No. 6X lode mining claim was located by M. H. White on the 1st day of September, 1966.

The general course of said vein or lode, as near as it may be described is N. 17° W and S. 17° E.

The claim is situated in the Bootstrap mining district, Eureka County, State of Nevada, and the discovery monument is located approximately N. 79° E. 4165 feet from the southwest corner Section 15, T. 36 N.; R. 49 E.; M. D. B. & M.

The locator claims 50 feet in a N. 17° W direction and 1450 feet in a S. 17° E direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claims are as follows: two rotary drill holes, 130 feet deep and 110 feet deep, on the Rio No. 4X claim, and casting more than \$500.00.

Such work was done at 2 point(s) within a group of contiguous claims and results in tending to advance the exploration of such claims as a group. The names of which said group of claims are as follows: Rio Nos. 3X, 4X, 5X, 6X and 7X.

The corners and side centers of this claim are located and marked as follows: Beginning at the northwest corner, a 4"x4"x4 1/2' wood post marked N.W. corner Rio No. 6X; thence S. 17° E. 750 feet, west side center, a 4"x4"x4 1/2' wood post marked W. side center, Rio No. 6X, 1500 feet to the SW. corner, a 4"x4"x4 1/2' wood post marked SW. corner Rio No. 6X; thence N. 73° E. 600 feet to the southeast corner, a 4"x4"x4 1/2' wood post marked SE. corner Rio No. 6X; thence N. 17° W. 750 feet, east side center, a 4"x4"x4 1/2' wood post marked E. side center, Rio No. 6X, 1500 feet to the NE. corner, a 4"x4"x4 1/2' wood post marked NE. corner Rio No. 6X; thence S. 73° W. 600 feet to the northwest corner, the place of beginning.

The west side line of this claim is contiguous with the east side line of the Rio No. 7X claim; the northend line is contiguous with the southend line of the Rio No. 6 claim; the east side line is contiguous with the west side line of the Rio No. 5X claim; the end line is contiguous with the end line of the claim.

All location work necessary to complete this location had been performed by October 17, 1966.
