7 DECREE SETTLING FINAL ACCOUNT OF ADMINI-
8 STRATOR AND FINAL DISTRIBUTION.

9 ANGELO TOGNONI and ROSE HERRERA, joint administrators of the
10 estate of BAPTISTA TOGNONI, deceased, having on the 30th day of
11 September, 1955, rendered and filed herein a full account and
12 report of their administration of said estate, which said account
13 was for a final settlement, and having with said account filed
14 a petition for the final distribution of said estate, and said
15 account and petition this day coming on regularly to be heard,
16 and proof having been made to the satisfaction of the court that
17 the clerk had given notice of the settlement of said account and
18 the hearing of said petition, in the manner and for the time
19 required by law, the court finds:

20 1. That said account is in all respects true and correct, and
21 that it is supported by proper vouchers; that the residue of money
22 in the hands of the administrators at the time of filing said
23 account was \$ 7,815.91.

24 2. That due and legal notice to creditors of said estate has
25 been given in the manner and for the time required by law.

26 3. That all claims and debts against said decedent and
27 against said estate, all inheritance taxes due from the distributees
28 and all personal property taxes due and payable by the estate, and
29 all debts, expenses and charges of administration have been fully
30 paid and discharged, and that said estate is ready for distribution
31 and now in a condition to be closed.

32 4. That since the rendition of said account there has been

1 received by said administrators the sum of \$ 1258.30; that the
 2 sum of \$ 974.79, has been expended by them as necessary
 3 expenses of administration, the vouchers thereof, together with a
 4 statement of such expenses and disbursements, are now presented
 5 and filed for settlement and allowance; that the estimated expenses
 6 of closing the estate will amount to \$ --.

7 5. That the whole of said estate was the separate property of
 8 said decedent.

9 6. That the statutory commissions payable upon the admini-
 10 stration of said estate to the joint administrators thereof are:
 11 \$ 364.22, and that the statutory fees, payable to the
 12 attorney for said joint administrators are \$ 610.57, none
 13 of which has been paid.

14 7. That said Baptista Tognoni died intestate, leaving him
 15 surviving the following heirs who are entitled to share in the
 16 residue of said estate, share and share alike, as hereinafter
 17 described, remaining for distribution:

26 It is therefore ordered, adjudged and decreed that the final
 27 account of said administrators, including their statement of
 28 expenses and disbursements since the rendition of said account and
 29 estimate of expenses of closing the estate, be, and the same is
 30 hereby, finally settled, allowed, and approved.

31 It is further ordered, adjudged and decreed that the sum of
 32 \$ 364.22, for and on account of commissions allowed by law to
 33 the joint administrators, and the sum of \$ 610.57, on account
 34 of fees allowed by law, to Johnson W. Lloyd, attorney for the
 35 joint administrators, be and they are hereby allowed, authorized

1 and directed to be paid.

2 It is further ordered, adjudged and decreed that the residue
3 of said estate of Buptista Tognoni, deceased, hereinafter particu-
4 larly described, and any other property not now known or discovered,
5 which may belong to the said estate or in which said estate may
6 have an interest in, be, and the same is hereby distributed as
7 follows, to-wit:

8 To Rose Herrera, and undivided 1/7 share; to Elva
9 Recand, an undivided 1/7 share; to Elmo Tognoni,
10 an undivided 1/7 share; to Gladys Gonzales, an
11 undivided 1/7 share; to Angelo Tognoni, an undivided
12 1/7 share; to Pauline Siri, an undivided 1/7 share;
13 and to Joseph Tognoni, an undivided 1/7 share.

14 The following is a particular description of the said residue
15 of said estate referred to in this decree and of which distribution
16 is now ordered as aforesaid:

17 Cash on hand in bonds, and deposit with the
18 First National Bank of Nevada, Eureka Branch,
19 Eureka, Nevada.....\$ 7,926.02

20 One Eighth (1/8) interest of Baptista Tognoni,
21 deceased, in and to that certain real property
22 located in Eureka, Nevada, formerly owned by
23 Lana Tognoni, deceased, including personal
24 property therein, of an estimated value of....\$ 1,000.00
25 Said real property being Lots 3&4, in Block
26 46, with two frame houses.

27 Clothing and other personal property, consisting
28 of guns, saddle, bridle and other personal
29 effects of decedent, of an estimated value of..\$ 525.00
