The locator's claim 1500 feet in length 900 FEET NORTHERLY AND 600 FEET SOUTH EASTERLY DIRECTION FROM THE POINT OF DISCOVERY

along the course of said vein or lode each way from the point of discovery with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and location of the discovery shaft work is APP. 200' S. E. OF W. S. C. OF GALE #1
10' x 8' AVERAGING 3' DEEP

and the location and description of each corner with the markings thereon are as follows:

The NW corner is marked by a ROCK MD. CEDAR POST 4 1/2 feet high inscribed NW corner of GALE #1 mine:
the NE corner is marked by a ROCK MD. AND POST 4 1/2 feet high inscribed NE corner of GALE #1 mine.
The SW corner is marked by POST AND ROCK MD 4 1/2 feet high, inscribed SW corner GALE #1 mine: the SE corner is marked by a ROCK MD. AND POST 4 1/2 feet high, inscribed SE corner GALE #1 mine. There is a SIDE CENTER

at each corner of each line. The discovery work has been done and the location work completed since NOVEMBER 6,
