The South half of the Northeast quarter of the Southwest quarter of Section 29, Township 29 North, Range 48 East, M.D.B. & M., as per Government Survey.

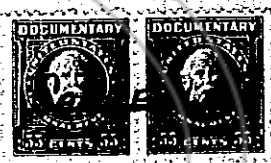
RESERVING THEREFROM an easement of 30 feet along all boundaries for ingress and egress, with power to dedicate.
