

CERTIFICATE OF LOCATION

Revised Laws, Sec. 2424

The Undersigned, hereby certifies that he has located a mining claim in the unknown Mining District, County of Eureka, State of Nevada, on a vein or lode known as the NERO TOO

The general course of said lode or vein, as near as it may be described, is North about 25° EAST

The name of the locator Julian E. Simpson

The said claim was located on the 8th day of September A. D. 1966, and is described in respect to* From corner no. 1 of the NERO TOO Claim, the SE corner of Section 36, T23N, R49E, Mt. Diablo Meridian bears about S40° - 30' W, about 16,990 feet,

The locator claim 1500 feet in length on said lode, 520 feet running about N 25° E from the center of the discovery monument and, 980 feet running about S 25° W from the center of the discovery monument along the course of said vein or lode each way from the point of discovery with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and location of the discovery shaft work is excavation work done at various points on the NERO and NERO TOO claims which are contiguous, such work aggregating in excess of \$ 200 for the two contiguous claims.

and the location and description of each corner with the markings thereon are as follows:

The Northeast No. 1 corner is marked by a 4" X 4" post 4 1/2' feet high and is inscribed Nero Too 1X corner of Nero Too mining claim mine: the northeast no. 2 corner is marked by a 4" X 4" post 4 1/2' feet high and is inscribed corner no. 2 corner of Nero Too mine. The Southwest no. 3 corner is marked by 4" X 4" post 4 1/2' feet high, inscribed corner no. 3 corner NERO mine: the southeast no. 4 corner is marked by a 4" X 4" post 4 1/2' feet high, inscribed corner no. 4 corner Nero Too mine. There is a 4" X 4" post, 4 1/2' feet high, at the center of each side line marked ESC and WSC of the NERO TOO at each corner of each line. The discovery work has been done and the location work completed since December 2, 1966
