

SUPPLEMENTAL DEED OF TRUST

THIS SUPPLEMENTAL DEED OF TRUST made this 30th day of November, 1966, by and between DON C. ENTZ and JOAN MAE ENTZ, husband and wife, and EUREKA RANCH CO., a copartnership comprised of J. W. ENTZ, D. C. ENTZ, A. B. CLEMENTS and T. C. ANDERSON, hereinafter referred to as "Trustors", and NEVADA TITLEGUARANTY COMPANY, a corporation organized and existing by virtue of the laws of the State of Nevada, hereinafter referred to as "Trustee", for JOHN B. CONLAN; MARK GAYLE and PATRICIA GAYLE, husband and wife; DONALD GRENIER, and DANIEL NELSON and HELEN NELSON, husband and wife, hereinafter referred to as "Beneficiaries".

W I T N E S S E T H:

That Trustors DON C. ENTZ and JOAN MAE ENTZ, with respect to Parcel No. 1, and Trustor EUREKA RANCH CO., with respect to Parcel No. 2, do hereby grant, bargain, sell and convey and confirm unto the Trustee, in trust with power of sale, all of their right, title and interest in and to their respective properties in the County of Eureka, State of Nevada, described as follows:

and the

ferred to as "Trustors", the Trustee is Trustee, and CONLAN  
LAND & LIVESTOCK, INC., a Nevada corporation, is beneficiary  
(the beneficiary's interest having been assigned to the Bene-  
ficiaries herein by mesne assignments), which Deed of Trust was

County REcorder of Eureka County in Book I Page 304 Real Mort-  
gage Records , as additional security for the payment of the

Trustor's obligations thereunder.




