8 of survivorship, and not as tenants in common, parties of the second part;

12 good and valuable considerations, to her in hand paid by the said parties of
13 the second part, the receipt whereof is hereby acknowledged, she by these

15 their survivor, survivor's heirs and assigns, all those certain lots, or
16 parcels of land situate, lying and being in the County of Eureka, State of
17 Nevada, and more particularly described as follows, to-wit:

19 Section 12: Possessory Interest in land approximately in
the NE 1/4 of SE 1/4; NW 1/4 of SW 1/4.

20 The South 17 feet of Lot 4 and all of Lot 5, Block 26,
21 Town of Eureka, County of Eureka, State of Nevada.

22 TOGETHER WITH ALL AND SINGULAR the tenements, heredita-
23 ments and appurtenances thereunto belonging or in anywise appertaining, and
24 the reversion and reversions, remainder and remainders, rents, issues and
25 profits thereof.

26 TO HAVE AND TO HOLD, ALL AND SINGULAR the said premises
27 together with the appurtenances unto the said parties of the second part, their
28 survivor, survivor's heirs and assigns forever. .

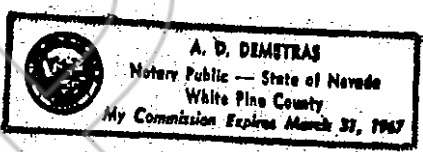
