WITNESSETH, That the said parties of the first part, for and in consideration of the sum of Twenty Seven Thousand Two Hundred Twenty & No/100 DOLLARS lawful money of the United States, do... by these presents GRANT, BARGAIN, SELL AND CONVEY unto the said part.Y of the second part, and to its heirs and assigns FOREVER, all that certain real property situate in the County of Eureka and State of Nevada, and bounded and particularly described as follows, to-wit: Approximately 598 Acres located in the vicinity of Eureka, Nevada as follows: Lots 2,3,& 4: The North Half of the Northeast Quarter (N $\frac{1}{2}$ NE $\frac{1}{4}$) and the North Half of the Northwest Quarter (N $\frac{1}{2}$ NW $\frac{1}{4}$), Section Thirty-Six (36), Township Twenty-one (21) North, Range Fifty-Three (53) East, M.D.B.&M. and Lots 9,10,11,& 12 in Section One (1) Township Twenty (20) North, Range Fifty Three (53) East M.D.B.&M. and Lot One (1) and the Southwest Quarter of Section Thirty-Six (36) Township Twenty-one (21) North, Range Fifty Three (53) East M.D.B.&M.

together with the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining.

THIS GRANT is intended as a mortgage to secure the payment of that certain promissory note... of even date herewith, executed and delivered by the said LaVerne D. Machacek & Eunice M. Machacek,

to the said part.Y of the second part: A Promissory Note dated December 12, 1966 in the amount of Twenty Seven Thousand Two Hundred Twenty & No/100 Dollars due November 12, 1967

AND THESE PRESENTS Shall be void if such payment be made. But in case default shall be made in the payment of the said principal sum... of money or any part thereof as provided in the said note... or if the interest be not paid as herein specified, or if the taxes, water maintenance, or payments of principal or interest on any prior lien or incumbrance be not paid, second part.Y shall have the right to pay the same, and then it shall be optional with the said part...Y of the second part... its executors, administrators or assigns to consider the whole of said principal sum... expressed in said note... as immediately due and payable; and immediately to enter into and upon all and singular the above described premises and to sell and dispose of the same according to law, and out of the money arising from such sale retain the principal and interest which shall then be due on the said promissory note..., together with the costs and charges of foreclosure suit, including reasonable counsel fees and also the amounts of all such payments of taxes, assessments, encumbrances or insurance as may have been made by the said second part.Y., its heirs, executors or assigns, with the interest on the same at the rate of .8 per cent per annum rendering the overplus of the purchase money (if any there shall be) unto the said parties of the first part, their heirs, executors, administrators, or assigns.
