of the center of the ledge for the entire length of the claim.

The discovery work consists of pit situated about 50
feet in a north-east direction from the location monument and its demensions are
10 feet wide, 6 feet long and 4 feet deep, exposing ledge,
lode or vein in place, and was completed on January 16 1966.
