ORDER APPROVING SECOND  
ACCOUNT AND DECREE OF  
DISTRIBUTION

12 The Second Account and Petition for Distribution of THOMAS O.  
 13 BATH, Executor herein, having been filed herein and the matter having been  
 14 noticed for hearing on the 16th day of February, 1955, and the same having  
 15 been continued by order of the Court until this, the 18th day of February,  
 16 1955; and being present in Court, the said Executor and C. E. HORTON, ESQ.,  
 17 of the firm of GRAY AND HORTON, ESQS., Attorneys for said Executor; and  
 18 there being personally present in Court, ANGEL D. FLORIO by and with  
 19 WILLIAM J. FORMAN, ESQ., of the firm of WOODBURN, FORMAN AND  
 20 WOODBURN, ESQS., Attorneys for said ANGEL D. FLORIO; and it appear-  
 21 ing to the Court and the Court so finding that all other parties interested herein  
 22 were given notice as by law required, and the Court having taken testimony in  
 23 open Court adduced by and on behalf of the said Executor and by and on be-  
 24 half of the said ANGEL D. FLORIO in support of said Second Account and  
 25 Petition for Distribution; and the matter having been submitted and the Court  
 26 having considered the same and upon good cause appearing therefor;

27 IT IS HEREBY ORDERED, that said Second Account be, and the  
 28 same is hereby, approved, ratified, settled and found true and correct in all  
 29 respects.

30 IT IS HEREBY FURTHER ORDERED, that upon the said ANGEL  
 31 D. FLORIO furnishing bond, to be approved by the Court, in the sum of Nineteen  
 32 thousand Thousand Five Hundred Fifty-five Dollars and Fifty Cents (\$19,555.50),

1 the sum of Nineteen Thousand Five Hundred Fifty-five Dollars and Fifty  
 2 Cents (\$19,555.50) be by said Executor delivered to the said ANGEL D.  
 3 FLORIO, as Guardian of the estate of ANGEL CAROL FLORIO, which said  
 4 sum of Nineteen Thousand Five Hundred Fifty-five Dollars and Fifty Cents  
 5 (\$19,555.50) represents the balance remaining after deducting from the sum  
 6 of Twenty-one Thousand Seven Hundred Dollars (\$21,700.00) set forth in said  
 7 Second Account, the sum of One Thousand One Hundred Dollars (\$1,100.00)  
 8 in virtue of an amendment of Paragraph IX, Page 5 of said Second Account  
 9 wherein the words and figures "eight hundred and fifty (850) pounds" were  
 10 amended to read "eight hundred (800) pounds", and after further deducting  
 11 the sum of One Thousand Forty-four Dollars and Fifty Cents (\$1,044.50)  
 12 found by the Court to be a credit in favor of the said ANGEL D. FLORIO as a  
 13 result of payments made by the said ANGEL D. FLORIO on account of an  
 14 educational insurance policy carried in favor of the said ANGEL CAROL  
 15 FLORIO.

16 IT IS HEREBY FURTHER ORDERED, that the said Executor be,  
 17 and he is hereby, authorized and directed to execute and deliver to the said  
 18 ANGEL D. FLORIO, as Guardian of the estate of the said ANGEL CAROL  
 19 FLORIO, the necessary instruments of title to those certain properties to which  
 20 the said ANGEL CAROL FLORIO is entitled under the terms of the Last Will  
 21 and Testament of the above named decedent and pursuant to that certain Stip-  
 22 ulation entered into in Case No. 2557 in the above entitled Court under date  
 23 of June 3, 1953, which said properties generally mentioned in Paragraph VII  
 24 of said Second Account and Petition for Distribution are by said Executor to be  
 25 conveyed, transferred, and set over to the said ANGEL D. FLORIO, as Guard-  
 26 ian, subject to the contingent interests of the said ANGEL D. FLORIO,  
 27 JOSEPHONE ELIZABETH FLORIO GIBELINE, and ALICE AIMEE FLORIO,  
 28 such contingent interests to be described in such executed instruments of title  
 29 as to conform with the stipulations set forth in the above referred to Case No.  
 30 2557.

31 IT IS HEREBY FURTHER ORDERED, that that certain Lease of  
 32 the Hay Ranch mentioned in said Second Account be delivered by said Executor

1 to the said ANGEL D. FLORIO, as Guardian of the estate of the said ANGEL  
2 CAROL FLORIO.

3 IT IS HEREBY FURTHER ORDERED, that said Executor deliver  
4 to the said ANGEL D. FLORIO that certain Promissory Note in the sum of  
5 Fifty-five Thousand Dollars (\$55,000.00) and the Deed of Trust securing the  
6 same on the Romano and Sulphur Ranches.

7 IT IS HEREBY FURTHER ORDERED, that said Executor deliver  
8 to the said ANGEL D. FLORIO all of the assets of the Eureka Water Works,  
9 and that thereunto said Executor is hereby authorized to execute all necessary  
10 deeds, instruments, and amendments of title.

11 IT IS HEREBY FURTHER ORDERED, that said Executor be, and  
12 he is hereby, authorized to deliver to ED C. DELANEY, as Trustee on behalf  
13 of CONEY CLIFFORD, the sum of Six Thousand Dollars (\$6,000.00), which  
14 said sum shall be, by the said ED C. DELANEY, held and disbursed for the  
15 benefit, support, and maintenance of the said CONEY CLIFFORD during his  
16 lifetime, with any balance thereof remaining in said fund at the time of the  
17 death of the said CONEY CLIFFORD to be paid over to the said ANGEL D.  
18 FLORIO.

19 IT IS HEREBY FURTHER ORDERED, that said Executor be, and  
20 he is hereby, authorized and directed to execute and deliver to EDWARD A.  
21 MELKA and HELEN MELKA, husband and wife, a Deed to the Southwest  
22 Quarter ( $\frac{1}{4}$ ) of the Southeast Quarter ( $\frac{1}{4}$ ) and the Southeast Quarter ( $\frac{1}{4}$ ) of  
23 the Southwest Quarter ( $\frac{1}{4}$ ) of Section 24, Township 20 North, Range 53 East,  
24 M. D. N. & M.

25 IT IS HEREBY FURTHER ORDERED, that said Executor be, and  
26 he is hereby, authorized and directed to release that certain mortgage wherein  
27 the above named decedent was mortgagee and MR. and MRS. JOHN VENTUR-  
28 INO were the mortgagees, and the subject matter of which said mortgage is the  
29 Sawm Hotel in Eureka, Nevada.

30 IT IS HEREBY FURTHER ORDERED, that said Executor be, and  
31 he is hereby, authorized to pay to GEORGE SWALLOW the sum of One Hun-  
32 dred Dollars (\$100.00); to ED HALSTEAD the sum of One Hundred Fifteen

1 Dollars (\$115.00); and to MRS. DICK GIBSON the sum of One Hundred Dollars  
2 (\$100.00) for services rendered as Appraisers herein. The additional sum of  
3 Fifteen Dollars (\$15.00) herein ordered to be paid to ED HALSTEAD covers  
4 mileage expense.

5 IT IS HEREBY FURTHER ORDERED, that said Executor be, and  
6 he is hereby, authorized to pay forthwith from the assets of said estate to the  
7 firm of GRAY AND HORTON the sum of One Thousand One Hundred Ninety-  
8 seven Dollars and Twenty-one Cents (\$1,197.21) reimbursing said firm for  
9 monies advanced for and on behalf of said executor and said estate.

10 IT IS HEREBY FURTHER ORDERED, that said Executor be, and  
11 he is hereby, authorized to retain in the estate checking account the sum of  
12 Seventeen Thousand Five Hundred Dollars (\$17,500.00) pending the disposition  
13 and resolution of contingent Federal Estate Tax liability.

14 IT IS HEREBY FURTHER ORDERED, that said Executor be, and  
15 he is hereby, authorized to retain such reasonable sum as is deemed necessary  
16 for paying recording and filing fees and other closing costs in connection with  
17 the within estate.

18 IT IS HEREBY FURTHER ORDERED, that said Executor execute  
19 and deliver to the said ANGEL D. FLORIO a Bill of Sale of those certain  
20 brands constituting part of the assets of the within estate as follows:

22 IT IS HEREBY FURTHER ORDERED, that upon compliance by  
23 the Executor of the orders hereinabove, that the residue of said estate, except  
24 as hereinabove otherwise provided, be and the same is hereby distributed to the  
25 said ANGEL D. FLORIO.
