WITNESSETH:

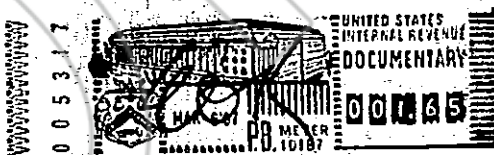
