

DEED OF GIFT

THIS DEED, made this 20th day of March, 1967, between MARY RAND BAILEY, a widow, of Pine Valley in the County of Eureka, State of Nevada, hereinafter referred to as the DONOR, and her son, WALLACE HALE BAILEY, of Pine Valley in the County of Eureka, State of Nevada, hereinafter referred to as the DONEE,

WITNESSETH:

That the Donor, in consideration of her natural love and affection for the Donee, does hereby give, grant, and convey to the Donee, his heirs and assigns, as his sole and separate property, and not as community property, all the following described real property in the County of Eureka, State of Nevada:

In Township Thirty North (T30N), Range Fifty-two East (R52E),  
M. D. B. & M.

Section 21: East one half ( $E\frac{1}{2}$ ), and the East one-half ( $E\frac{1}{2}$ )  
of the Southwest Quarter ( $SW\frac{1}{4}$ );

Section 32: All of Southeast Quarter ( $SE\frac{1}{4}$ ); Northeast Quarter  
( $NE\frac{1}{4}$ ) of Northwest Quarter ( $NW\frac{1}{4}$ ); Northwest Quarter ( $NW\frac{1}{4}$ )  
of Northeast Quarter ( $NE\frac{1}{4}$ ); South one-half ( $S\frac{1}{2}$ ) of Northeast  
Quarter ( $NE\frac{1}{4}$ );

Section 33: All of said section.

In Township Twenty-nine North (T29N), Range Fifty-two East  
(R52E), M. D. B. & M.

Section 5: Fraction East one-half ( $E\frac{1}{2}$ ) of Northeast Quarter ( $NE\frac{1}{4}$ );

Section 4: West one-half ( $W\frac{1}{2}$ ) of Northwest Quarter ( $NW\frac{1}{4}$ );


TOGETHER with all stock watering rights, range and range rights now or heretofore used upon or enjoyed in connection with any of the described lands; together with all range rights under the Taylor Grazing Act.

EXCEPTING AND EXCLUDING from each and every parcel of land described above in Sections Twenty-one (21), and Thirty-three (33), save and except that part of the West one-half ( $W\frac{1}{2}$ ) of the West one-half ( $W\frac{1}{2}$ ), of Section Thirty-three (33), lying West of the center

line of the Eureka and Palisade Railroad track comprising Sixty (60) acres, more or less, all petroleum, oil, natural gas and products derived therefrom, and all rights thereto, together with the exclusive right at all times to enter upon or in said land to prospect for, and to drill for, recover and remove the same, as the same has heretofore been accepted and reserved by the Southern Pacific Land Company, a corporation, by deeds of record, for itself and its successors and assigns.

ALSO EXCEPTING AND EXCLUDING one-half ( $\frac{1}{2}$ ) interest in and to any and all other mineral rights in those parcels of land described in the paragraph next hereinabove, together with the right to enter on said lands to prospect for, recover and remove the same, as the same has heretofore been excepted and reserved by the Eureka Livestock Company, a partnership, by deeds of record.

TOGETHER WITH about one hundred (100) head of cattle, more or less, and about twelve (12) horses, more or less, now situate upon the above described property,

TOGETHER WITH a 2S  brand iron and all rights connected therewith.

TOGETHER with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise pertaining, and the reversion and reversions, remainder and remainders, rents, issues, and profits thereof.

TO HAVE AND TO HOLD the said premises, together with the appurtenances, unto the Donee as his sole and separate property, and not as community property, and to his heirs and assigns forever.

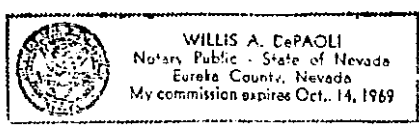

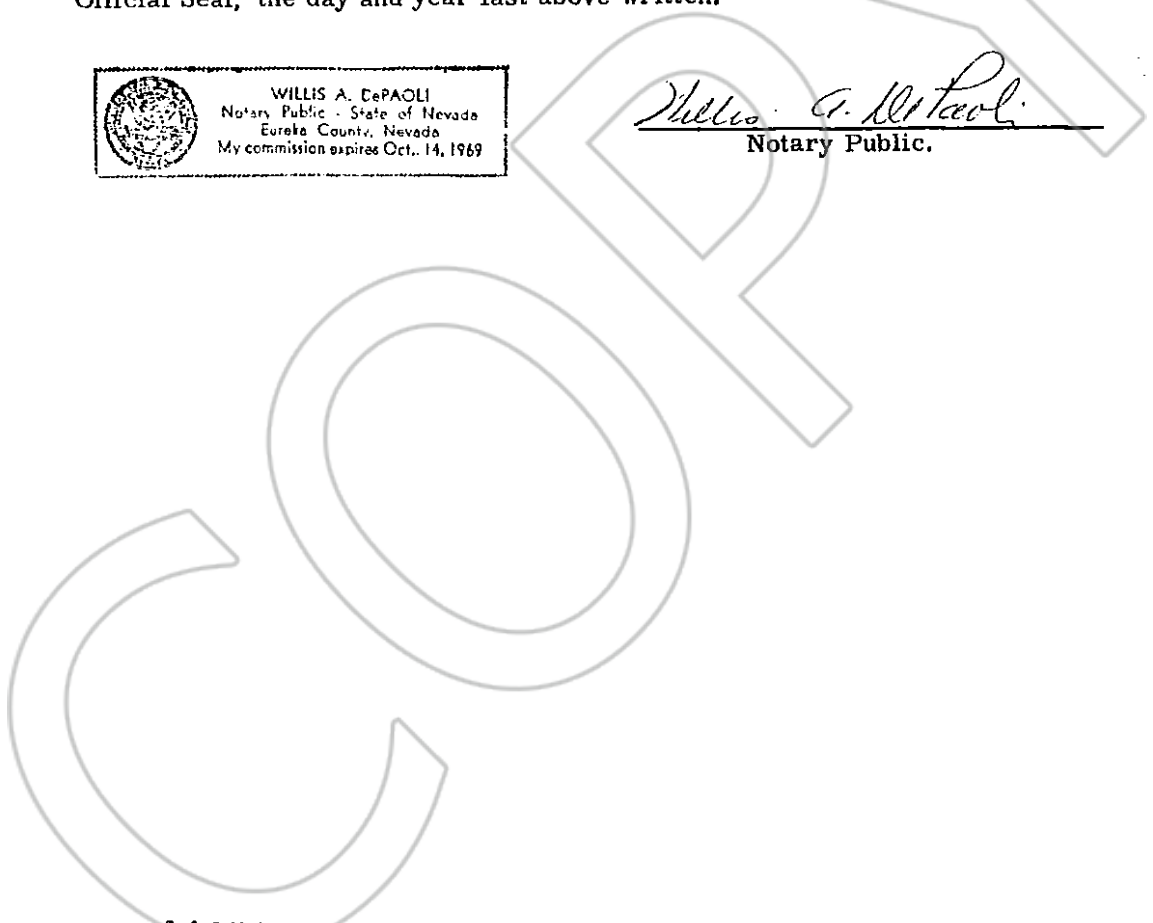
