

WARRANTY DEED

THIS INDENTURE made this 23rd day of March, 1967, between HORSESHOE CATTLE COMPANY, a Nevada corporation, Party of the First Part, sometimes herein-after referred to as Grantor, and CARLIN GOLD MINING COMPANY, a Delaware corporation qualified to engage in business and hold property in Nevada, Party of the Second Part, sometimes hereinafter referred to as Grantee.

W I T N E S S E T H:

Grantor, in consideration of the sum of ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000), lawful money of the United States, receipt of which is hereby acknowledged, hereby grants, bargains and sells and conveys unto Grantee, its successors and assigns forever, all Grantor's right, title and interest in any and all minerals, other than oil and gas, in, on and under the lands described on Exhibit A hereto attached and situate in Eureka, Lander and Elko Counties, State of Nevada, all Grantor's right, title and interest being an undivided one-half (1/2) of all right, title and interest in any and all minerals, other than oil and gas, in, on and under said property, and sometimes hereinafter referred to as "said mineral interest".

TOGETHER WITH, all and singular, the tenements, hereditaments and appurtenances thereunto belonging or



in anywise appertaining to said mineral interest, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof, as well in law as in equity.

TO HAVE AND TO HOLD the same unto said Grantee, its successors and assigns forever; and the said Grantor does hereby covenant with the said Grantee, its successors and assigns, that the said mineral interest is free from all encumbrances by it made, permitted or suffered, that it has not previously conveyed the same, and that it has good right and lawful authority to sell the same, and that it hereby warrants and agrees forever to defend the title to said mineral interest against the just and lawful claims and demands of all persons claiming or to claim the same by, through or under said Grantor.


