

AGREEMENT

THIS AGREEMENT made this 3<sup>rd</sup> day of April, 1967, between PETE KELLEY and PETER MERIALDO, the Parties of the First Part, present owners of a seventy-five percent (75%) interest in and to the hereinafter described mining properties, and FRANK FOSTER and HARRY STROUD, the Parties of the Second Part;

WITNESSETH:

That the Parties of the First Part, in consideration of the covenants and agreements on the part of the Parties of the Second Part hereinafter contained, agree to sell and convey unto the Parties of the Second Part, their heirs or assigns, and the Parties of the Second Part agree to buy, all the right, title and interest of the First Parties in and to those certain patented mining claims situate in the Fish Creek Mining District, County of Eureka, State of Nevada, more particularly described as follows:

Two patented mining claims:

Antelope North; and  
Antelope South,

together with the tenements, hereditaments, appurtenances, rights and easements thereunto belonging or in any wise appertaining, for the total sum of ONE THOUSAND DOLLARS (\$1,000.00), lawful money of the United States of America, and the Parties of the Second Part, in consideration of the premises, agree to pay to the Parties of the First Part the said sum of ONE THOUSAND DOLLARS (\$1,000.00), at the times and in the manner following, to-wit: The sum of FIVE HUNDRED DOLLARS (\$500.00) to be paid upon the signing of this Agreement, the receipt whereof by the Parties of the First Part is hereby acknowledged; and the further sum of FIVE HUNDRED DOLLARS (\$500.00) to be paid on or before the 30th day of June 1967.

Both parties hereby agree that all taxes are to be apportioned as of the date of this Agreement, and the Parties of the Second Part agree to pay any and all taxes assessed following the

1 date of this Agreement.

2 And the Parties of the First Part, on receiving said final  
3 payment, at the time and in the manner above set forth, agree to  
4 execute and deliver to the Parties of the Second Part, or to their  
5 heirs or assigns, a good and sufficient deed conveying their said  
6 seventy-five percent (75%) interest in and to said properties free  
7 and clear of all liens and encumbrances made, done, or suffered by  
8 the Parties of the First Part.

9 And it is understood and agreed that the covenants and  
10 agreements aforesaid are to apply to and bind the heirs, executors,  
11 administrators and assigns of the respective parties; and that the  
12 Parties of the Second Part shall be entitled to the free and un-  
13 encumbered possession of the premises above described, and the  
14 right to work, and remove and sell for their own account all ores  
15 and minerals from said premises, so long as the said Parties of  
16 the Second Part are not in default hereunder.
