









WARRANTY DEED

THIS INDENTURE made this 7th day of Vocantian 1966, between M. M. & S. EXPLORATION COMPANY, a Nevada corporation, Party of the First Part, sometimes hereinafter referred to as Grantor, and CARLIN GOLD MINING COMPANY, a Delaware corporation qualified to engage in business and hold property in Nevada, Party of the Second Part, sometimes hereinafter referred to as Grantee.

WITNESSETH:

HUNDRED THIRTY-SEVEN THOUSAND THREE HUNDRED SIXTY-EIGHT DOLLARS (\$237,368), lawful money of the United States, receipt of which is hereby acknowledged, hereby grants, bargains and sells and conveys unto Grantee, its successors and assigns forever, all that certain land situate in Eureka County, State of Nevada, described as follows:

North Half (N) of the Northwest Quarter (NW) of Section 13, Township 35 North, Range 50 East, SCM U.M. W. h.M. M.D.B.&M.,

together with any and all mining claim or claims located thereon but reserving to Grantor any mineral rights in Sections 10, 11 and 12 to the North as a result of the Apex law.

TOGETHER WITH, all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof, as well in law as in equity.

Grantee, its successors and assigns forever; and the said Grantor does hereby covenant with the said Grantee, its successors and assigns, that the said land is free from all encumbrances by it made, permitted or suffered, that it has not previously conveyed the same, and that it has good right and lawful authority to sell the same, and that it hereby warrants and agrees forever to defend the title to the said premises against the just and lawful claims and demands of all persons claiming or to claim the same by, through or under said Grantor.


