

AMENDED CERTIFICATE OF LOCATION LODE CLAIM

THIS IS TO CERTIFY that the CHRISTINA lode mining claim was located by Neil O'Donnell, Box 1245, Thousand Oaks, California, on the 13th day of August, 1966, situated in the Unknown Mining District, Eureka County, State of Nevada, and that said Certificate of Location was recorded in Book 11 of Official Records, page 515, as File No. 42453, on August 19, 1966, Records of Eureka County, Nevada.

Notice is hereby given that the undersigned Neil O'Donnell, as Locator of the said CHRISTINA lode mining claim and preserving all rights under the said original location thereof does hereby amend the description of this claim, correcting the location contained in the original certificate, as recorded in the manner hereinafter set forth. The size, outline, and field position of the claim remains as originally recorded, and this amended location certificate is to properly identify the correct township and range on which the claim is actually located, as follows:

This claim is situated in the Unknown Mining District, Eureka County, State of Nevada, in Section 26, T. 34 N., R. 51 E., M.D.B.&M.

The locator claims 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 100 feet from the location monument in a NW direction, and 1400 feet in a SE direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The Location work with respect to this claim was done in connection with the work on a group of contiguous claims, which work was done for the benefit of all such claims. The names of such claims within such contiguous group are: Jeanna, Christina, Tammy, Julie and John. The location work consists of stripping 600 ft. x 15 ft. x 3 ft. deep on the Jeanna Claim and drill site preparation performed on the Christina Claim. The Total cost of said work was in excess of \$500.00.

The northwest corner is marked by a STAKE 4 feet high, inscribed "NW Corner of the CHRISTINA Claim"; the southwest corner is marked by a STAKE 4 feet high, inscribed "SW Corner of the CHRISTINA Claim"; the

southeast corner is marked by a STAKE 4 feet high, inscribed "SE  
Corner of the CHRISTINA Claim"; the northeast corner is marked by a  
STAKE 4 feet high, inscribed "NE Corner of the CHRISTINA Claim."  
There is also a STAKE at the center of each side line. The discovery  
work has been done, and the location completed since August 13, 1966.
