

**ASSIGNMENT**

THIS ASSIGNMENT made this 10<sup>th</sup> day of April, 1967,  
between HARRY STROUD, hereinafter called First Party, and RICHARD  
H. TAYLOR, hereinafter called Second Party:

1. WHEREAS, by an agreement in writing, dated the 3<sup>rd</sup>  
day of April, 1967, First Party and one Frank Foster  
agreed to purchase, and certain other parties, namely, PETE  
MERIALDO and PETE KELLEY, agreed to sell to them a Seventy-Five  
percent (75%) interest in and to the following described property:

Two (2) patented mining claims, known as  
the Antelope North and the Antelope South,  
located in the Fish Creek Mining District,  
Eureka County, Nevada.

2. AND WHEREAS, First Party herein is now the owner of  
and is entitled to a one-third (1/3) interest in the said agree-  
ment, and is therefore and thereunder entitled to a Twenty-Five  
percent (25%) interest in the said two patented mining claims  
when the deed thereto is executed pursuant to said agreement.

NOW, THEREFORE, in consideration of the sum of TEN DOLLARS  
(\$10.00), herewith paid by Second Party to First Party, and other  
valuable considerations given by Second Party to First Party,  
receipt whereof is hereby acknowledged, First Party hereby assigns  
to Second Party one-half (1/2) of First Party's interest in, to and  
under the above described contract and in and to all proceeds,  
benefits and results received by First Party therefrom, and  
specifically intending to convey and hereby conveying to Second  
Party a full Twelve and One-Half (12 1/2%) percent interest in and to  
the above described two patented mining claims.

And First Party agrees that the contract recited in  
Paragraph 1 above shall be duly performed and the patented mining  
claims acquired as in said contract set forth.

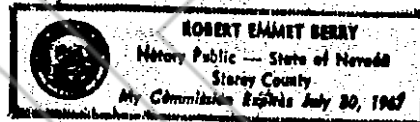
