

ASSIGNMENT

1 THIS ASSIGNMENT made this 10th day of April, 1967,
2
3 between HARRY STROUD, hereinafter called First Party, and RICHARD
4 H. TAYLOR, hereinafter called Second Party:

5 1. WHEREAS, by an agreement in writing, dated the 3rd
6 day of April, 1967, First Party and one Frank Foster
7 agreed to purchase, and certain other parties, namely, PETE
8 Merialdo and PETE KELLEY, agreed to sell to them a Seventy-Five
9 percent (75%) interest in and to the following described property:

10 Two (2) patented mining claims, known as
11 the Antelope North and the Antelope South,
12 located in the Fish Creek Mining District,
Eureka County, Nevada.

13 2. AND WHEREAS, First Party herein is now the owner of
14 and is entitled to a one-third (1/3) interest in the said agree-
15 ment, and is therefore and thereunder entitled to a Twenty-Five
16 percent (25%) interest in the said two patented mining claims
17 when the deed thereto is executed pursuant to said agreement.

18 NOW, THEREFORE, in consideration of the sum of TEN DOLLARS
19 (\$10.00), herewith paid by Second Party to First Party, and other
20 valuable considerations given by Second Party to First Party,
21 receipt whereof is hereby acknowledged, First Party hereby assigns
22 to Second Party one-half (1/2) of First Party's interest in, to and
23 under the above described contract and in and to all proceeds,
24 benefits and results received by First Party therefrom, and
25 specifically intending to convey and hereby conveying to Second
26 Party a full Twelve and One-Half (12 1/2%) percent interest in and to
27 the above described two patented mining claims.

28 And First Party agrees that the contract recited in
29 Paragraph 1 above shall be duly performed and the patented mining
30 claims acquired as in said contract set forth.



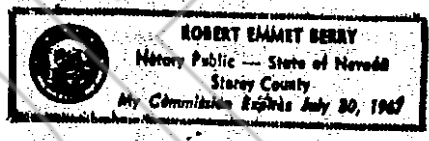
