KNOW ALL MEN BY THESE PRESENTS, that J. C. McFarlane, being first duly sworn, deposes and says:

That at the instance of the affiant, CARLIN GOLD MINING COMPANY, that it expended more than one hundred dollars (\$100.00) per claim for labor or improvements, as the annual assessment work for the year ending September 1, 1967, on or for the benefit of all the aforesaid claims, in the Lynn Mining District, Eureka County, Nevada, owned by Carlin Gold Mining Company, for the purpose of holding all of the aforesaid claims.

Said work was performed by employees, Worthington Construction Company and its employees, between the twelfth (12th) day of May, 1967, and thirtieth (30th) day of May, 1967, and that more than 28 days of labor were performed.

Such work or improvements, and character, consisted of repairing 9/10ths of a mile of old access road, constructing 8/10ths of a mile of new access road, re-opening of caved portal of a tunnel, cutting 5 trenches a total length of 750 feet with an average depth of 6 feet, geologic mapping, and engineering control. Most of the work was on and access to Par Claim No. 10.

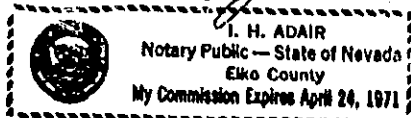
