## SUMMARY REPORT

Pursuant to your request, the writer has made on the ground investigations of the Chicago Group of claims owned by East Utah Mining Company during the year 1967. The Chicago Claims Group comprises six (6) unpatented lode mining claims in one contiguous block containing approximately one hundred twenty (120) acres. Names of the claims are:

Chicago No. 2 Chicago No. 7
Chicago No. 3 Chicago No. 8
Chicago No. 4 Chicago No. 9

The property is located in the south-central portion of Section 4, T 35N, R 50E, M.D.B.M., and lies contiguous with and/or adjacent to the Blue Star or Number 8 mine.

Work performed consisted of reconnaissance and detailed geologic mapping of the entire Chicago Claims Group, areal mapping on a district-wide basis in order to more properly evaluate the properties' mineral potential, and compilation of property data from in-the-field surveys to delineate boundaries.

Four drill site locations were placed on the ground. A grid system was laid out in North South-East West coordinates. The 0-0 East coordinate is laid along the east side line of the Chicago No. 3 lode mining claim and bears N 0° 7' 45" E. The 0-0 North coordinate lies 100 feet south of the east side center of the Chicago No. 3 lode mining claim and bears N 89° 53' W.

A geologic map at a scale of 1" = 400' on the Chicago Claims Group and property map on the Lynn Mining District at a scale of 1" = 1000' has been prepared and presented to you for use with a proposed exploration-development program. Total cost of this geologic examination-evaluation study is in excess of six hundred dollars (\$600.00). August 24, 1967

Basic findings of the surveys indicate that geologic factors similar to other known mineral properties within the Lynn Mining District (one of which is presently in production) occur within the boundaries of the Chicago Claims Group. Ore emplacement within the district and the Chicago Claims Group is controlled by at least three factors, two of which are quite obvious and the third somewhat more subtle, although of apparent equal importance.

An exploration-development program consisting of drilling, sampling, geochemical and geophysical disciplines has been prepared and presented. Objectives of this program are to test the basic geologic concepts of mineral emplacement in order to more properly evaluate the mineral potential of the Chicago Group. A comprehensive report covering the geologic work completed on the Chicago Group of claims up to and including August 24, 1967 is in the possession of East Utah Mining Company.

All of the technical work on the Chicago Group of claims was done by, or under the direct supervision and control of, M. C. Godbe, III, a graduate geologist with twenty (20) years' experience in exploration geology, who is presently employed as a consultant to the mineral industry on an individual-client basis.

This summary report has been prepared in conjunction with and as an integral part of the continuing evaluation program for the Chicago Claims Group. Specific data, conclusions and recommendations are considered to be the exclusive property of East Utah Mining Company. Under the provisions of P.L. 85-876, Act of September 2, 1958 (72 Stat. 1701; 30 U.S.C. 28-1-2) East Utah Mining Company intends to apply that portion of the total cost of this survey, which is well in excess of six hundred dollars (4600,00), toward the applied assessment work requirements for the (\$600.00), toward the annual assessment work requirements for the Chicago Claims Group.
