- (9.) 600 feet long, 12 feet wide, average depth $4\frac{1}{2}$ feet.

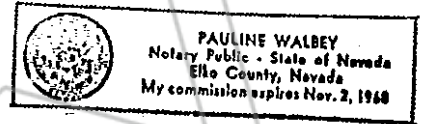
