THIS DEED, made this 18th day of September, 19 67,
 between the BOARD OF COMMISSIONERS, TOWN OF CARLIN, hereafter called
 GRANTOR, and the STATE OF NEVADA, on relation of its Department of Highways,
 hereafter called GRANTEE,

WITNESSETH

That the GRANTOR, for and in consideration of the sum of one dollar (\$1.00),
 lawful money of the United States of America and other good and valuable consideration,
 the receipt whereof is hereby acknowledged, and in accordance with Chapter 408 of
 the Nevada Revised Statutes does hereby remise, release and forever quitclaim unto
 the GRANTEE and to its assigns forever, for those purposes as contained in the
 aforesaid act, all of their right, title and interest in and to that certain real property
 together with any and all abutter's rights, including access rights appurtenant to the
 property being quitclaimed by said GRANTOR lying within Interstate Route 80; said
 real property situate, lying and being in the county of Eureka, State of Nevada,

Being that certain "original" easement contained within the Highway
 right of way of Interstate 80, beginning at a point 246 feet more or less
 right of Highway Engineer's Station "Ow" 884+42± in section 14 T. 32 N.,
 R. 50 E., M.D.B. & M.; thence, proceeding in a northeasterly direction
 across Sections 14, 13, and 12 of T. 32N., R. 50 E., M.D.B.&M., and
 continuing across Section 17, 16, T.32N., R. 51E., M.D.B.&M., and leaving
 the right of way of Interstate 80 at Highway Engineer's Station at a point 280
 feet more or less right of Highway Engineer's Station "Bw" 1035+90 plus or
 minus.

Being that certain "original" easement contained within the Highway
 right of way of Interstate 80, beginning at a point 200 feet right of
 Highway Engineer's Station "Ce" 1135+60± thence in a northeasterly direction
 and leaving the Highway right of way of Interstate 80 at Highway Engineer's
 Station "Ce" 1143+45±, across the W. 1/2 of Section 11, T. 32 N., R. 51 E.,
 M.D.B.&M. E.J.

To agree and hereby does agree that said GRANTEE and its assigns shall have the right of adopt and improve the whole or any part of said easement and right of way over said lands, subject to the provisions of the before-mentioned NRS 408.970.

To waive and hereby does waive, with full knowledge that a public highway and the necessary incidents thereto are to be located upon, over and across the lands hereinabove described, any claim for any and all damages to the remaining adjacent lands and property of the GRANTOR by reason of the location, construction, landscaping and maintenance of said highway and appurtenances in said location.

IN WITNESS WHEREOF, the said GRANTOR, by and through its officers thereunto duly authorized, has caused these presents to be executed and its corporate name and seal to be hereunto affixed the day and year first above written.
