

LOCATION CERTIFICATE

THIS IS TO CERTIFY that the Curlew No. 16 lode mining claim was located by Charles Damele Sr. et al 1/2 J D Ranch, Carlin Nevada 89822 Homestake Mining Company, whose present address is 650 California Street, San Francisco, California 94108, on the 21 day of July 19 67.

The general course of said vein or lode as near as it may be described is northerly and southerly. The claim is situated in unknown Mining District in Eureka County, State of Nevada, and the discovery monument is located approximately 2000 feet from the SW corner of Section 22, Township 25N Range 49E, ~~as shown on the accompanying sketch attached hereto.~~ The undersigned claims 1500 feet in a southerly direction, and — feet in a — direction from the point of discovery, with a width of 300 feet on each side of the center of the lode or vein along the entire length of the claim.

This is one of a group of 9 contiguous claims to-wit: Curlew 20; Curlew 16; Curlew 15; Curlew 10; Curlew 9; Curlew 8; Curlew 3; Curlew 2; & Curlew 1

The discovery work for the benefit of the entire group was done in the claim or claims as follows: Curlew 16

The corners and side centers of the claim are located and marked as follows:

Beginning at the northeast corner a 4-inch by 4-inch by 4 1/2 foot wooden post set in a mound of earth or stones 2 feet in height by 4 feet in diameter and marked "NE Cor. Curlew No. 16"; thence south 750 feet to the east side center post, a post of the same dimensions as that mentioned above surrounded by a mound of earth and stones as above described and marked "E Side Center Curlew No. 16"; thence south 750 feet to the southeast corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "SE Cor. Curlew No. 16"; thence west 600 feet to the south west corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "SW Cor. Curlew No. 16"; thence north 750 feet to the west side center post, a post of the same dimensions surrounded by earth and stones as above set forth and marked "W Side Center Curlew No. 16"; thence 750 feet north to the northwest corner of the claim a post of the same dimensions surrounded by earth and stones as set forth and marked "NW Cor. Curlew No. 16"; thence 600 feet east to the point of beginning.

All location work necessary to complete this location had been performed prior to October 5, 1967.

The location work on the group of claims hereinbefore referred to cost at least \$ 900.
