

THIS IS TO CERTIFY that the Curlew 18 lode mining claim was located by Charles Damele % J.D. Ranch, Carlin, Nevada 89822

The general course of said vein or lode as near as it may be described is easterly and westerly. The claim is situated in unknown Mining District in Eureka County, State of Nevada, and the discovery monument is located approximately 21000 feet from the SW corner of Section 22, Township 25 N Range 50 E, ~~as shown on the accompanying sketch attached hereto.~~ The undersigned claims 750 feet in a westerly direction, and 750 feet in a easterly direction from the point of discovery, with a width of 300 feet on each side of the center of the lode or vein along the entire length of the claim.

This is one of a group of 6 contiguous claims to-wit: snow cap No 4 ; snow cap No 3 ; snow cap No 2 ; Curlew No 17 ; Curlew No 18 & Curlew No 19

The discovery work for the benefit of the entire group was done in the claim or claims as follows: Curlew No 17

and consisted of: Two drill holes

~~and at the locations shown on the accompanying sketch attached hereto.~~

The corners and side centers of the claim are located and marked as follows:

Beginning at the northwest corner a 4-inch by 4-inch by 4 1/2 foot wooden post set in a mound of earth or stones 2 feet in height by 4 feet in diameter and marked "NW Cor. Curlew No 18"; thence east 750 feet to the North side center post, a post of the same dimensions as that mentioned above surrounded by a mound of earth and stones as above described and marked "N Side Center Curlew No 18"; thence east 750 feet to the NE corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "NE Cor. Curlew No 18"; thence south 600 feet to the SE corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "SE Cor. Curlew No 18"; thence W 750 feet to the South side center post, a post of the same dimensions surrounded by earth and stones as above set forth and marked "S Side Center Curlew No 18"; thence 750 feet W to the SW corner of the claim a post of the same dimensions surrounded by earth and stones as set forth and marked "SW Cor. Curlew No 18"; thence 600 feet North to the point of beginning.

All location work necessary to complete this location had been performed prior to September 22, 1967.

The location work on the group of claims hereinbefore referred to cost at least \$ 600.
