

THIS IS TO CERTIFY that the GOLDEN 17 lode mining claim was located by Charles Domele Sr. whose present address is 94D Ranch Corlin Nevada 89822, on the 20 day of July 1967.

The general course of said vein or lode as near as it may be described is easterly and westerly. The claim is situated in unknown Mining District in Eureka County, State of Nevada, and the discovery monument is located approximately 4000 feet from the NW corner of Section 16, Township 25N Range 49E. The undersigned claims 750 feet in a easterly direction, and 750 feet in a westerly direction from the point of discovery, with a width of 300 feet on each side of the center of the lode or vein along the entire length of the claim.

This is one of a group of 6 contiguous claims to-wit: Golden 22; Golden 21; Golden 20; Golden 19; Golden 18 & Golden 17

The discovery work for the benefit of the entire group was done in the claim or claims as follows: Golden 20 and consisted of: Three drill holes

The corners and side centers of the claim are located and marked as follows:
Beginning at the north west corner a 4-inch by 4-inch by 4 1/2 foot wooden post set in a mound of earth or stones 2 feet in height by 4 feet in diameter and marked "NW Cor. Golden 17"; thence east 750 feet to the north side center post, a post of the same dimensions as that mentioned above surrounded by a mound of earth and stones as above described and marked "N Side Center Golden 17"; thence east 750 feet to the north east corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "NE Cor. Golden 17"; thence south 600 feet to the south east corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "SE Cor. Golden 17"; thence west 750 feet to the south side center post, a post of the same dimensions surrounded by earth and stones as above set forth and marked "S Side Center Golden 17"; thence 750 feet west to the south west corner of the claim a post of the same dimensions surrounded by earth and stones as set forth and marked "SW Cor. Golden 17"; thence 600 feet north to the point of beginning.

All location work necessary to complete this location had been performed prior to October 12, 1967.

The location work on the group of claims hereinbefore referred to cost at least \$ 600
