WITNESSETH:

Reserving Therefrom: an easement of 30' along all boundaries for ingress and egress, with power to dedicate, and, except and and all oil rights, including the right of entry for exploration and production of oil or other carbohydrates.

TOGETHER WITH the tenements, hereditaments and appurtenances thereunto belonging or appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

Reserving Therefrom: a right of way, with right of entry upon, along, across, and through said land for purposes of erecting, constructing, operating, repairing to maintain pole lines of power and telephone, and or lines of water, gas, or of water, and right to convey sole right to convey the rights hereby reserved, and subject to all matters of record.

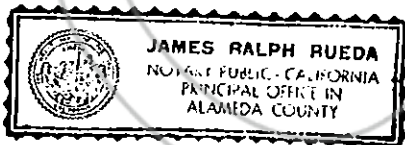
