

Deed

THIS INDENTURE, made and entered into this 10th day of October, 1967, by and between Dale N. Hansen and Patricia R. Hansen, husband and wife, party of the first part, and Frank Allen Thomas Jr. of 4140 Jefferson Ave. Woodside, California, taking title as his sole and separate property, party of the second part,

WITNESSETH:

That the said party of the first part, in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America, to it in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged; does by these presents grant, bargain and sell unto the said party of the second part, and to the survivor of him, and to the heirs and assigns of such survivor forever, all that certain piece or parcel of land situate in the County of Eureka, state of Nevada, described as follows:

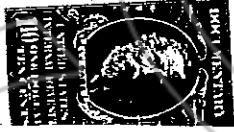
TOWNSHIP 31 NORTH 49 EAST, N. D. E. & M.

Reserving Therefrom, an easement of 30' along all boundaries for ingress and egress with power to dedicate; and, except any and all oil rights, including the right of entry for exploration and production of oil or other carbohydrates.

TOGETHER WITH the tenements, hereditaments and appurtenances thereunto belonging or appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

Reserving Therefrom, a right of way, with right of entry upon, along, across, and through said land for purposes of erecting, constructing, operating, repairing and to maintain pole lines of power and telephone, and or lines of water, gas, or of water, and right to convey sole right to convey the rights hereby reserved. And subject to all matters of record TO HAVE AND TO HOLD the said premises, together with the appurtenances, unto the said party of the second part, and to the survivor of them, and to the heirs and assigns of such survivor forever.

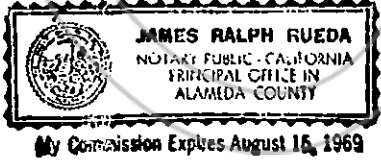
