

KNOW ALL MEN BY THESE PRESENTS:

1. That the undersigned, Roger A. Lillibridge, in preparing this Certificate of Amendment of Location, is acting for and on behalf of himself.

2. The name of the claim amended by this certificate is Ann No. 4 originally located on the 30th day of June, 1967, the original Certificate of Location being recorded in the Office of the County ~~Recorder~~ <sup>Recorder</sup> ~~Register and EX-Office~~ <sup>Register</sup> of Eureka County, Nevada, on the 12th day of September, 1967, in Book 20 at Page 343. (The original Certificate of Location is incorporated herein for all purposes by this reference.)

3. This Certificate is prepared, posted and recorded, as an amendment of the original location and to correct any error, irregularity, omission or incompleteness of said original location and without waiver, abandonment or release of any rights acquired or held under said initial or original location and is made by the locator and discoverer.

4. The general course of said vein or lode, as near as it may be described is north and south.

5. The claim is situated in the Eureka Mining District, Eureka County, State of Nevada, and lies in Section 27, Township 19 North, Range 53 East, MDM.

6. The locator claims 100 feet in a Northerly direction and 1400 feet in a Southerly direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

7. The dimensions and locations of the discovery work done on the claims are as follows: Drilling Rotary Drill Hole No. 705 to a depth of 300 feet on the Ann No. 13 Lode Mining Claims. Such work was done at a point within a group of contiguous claims and results intending to advance the exploration of such claims as a group. The names of which

said group of contiguous claims are as follows: Ann Nos. 3, 4, 5, 6, 7, 8, 9, 11, 12 and 13 Lode Mining Claims. The total cost of such work consisted of at least \$1,000.00.

8. The corners and side centers of this claim are located and marked as follows: From the northwest corner, a post marked Ann No. 4 NW Cor., thence in an easterly direction 600 feet to the northeast corner, a post marked Ann No. 4 NE Cor., thence 750 feet in a southerly direction to the east side center, a post marked Ann No. 4 ESC., thence 750 feet in a southerly direction to the southeast corner, a post marked Ann No. 4 SE Cor., thence 600 feet in a westerly direction to the southwest corner, a post marked Ann No. 4 SW Cor., thence 750 feet in a northerly direction to the west side center, a post marked Ann No. 4, WSC., thence 750 feet in a northerly direction to the northwest corner, the point of beginning.

9. Each of the above-described monuments is a post 4" x 4" diameter, by 4-1/2' long, set 1 foot in the ground.

The undersigned therefore reaffirms his claim and right to the property herein concerned under the laws of the United States and of the State of Nevada and in accordance with the customs prevailing in the mineral locality concerned.
