

LOCATION CERTIFICATE

THIS IS TO CERTIFY that the R-40 lode mining claim was located by Homestake Mining Company, whose present address is 650 California Street, San Francisco, California 94108, on the 2nd day of October 19 67.

The general course of said vein or lode as near as it may be described is east and west. The claim is situated in unknown Mining District in Eureka County, State of Nevada, and the discovery monument is located approximately 2200 feet from the NW corner of Section 28, Township 24N Range 149E, ~~as shown on the accompanying sketch attached hereto.~~ The undersigned claims 50 feet in a west direction, and 1450 feet in an east direction from the point of discovery, with a width of 300 feet on each side of the center of the lode or vein along the entire length of the claim.

This is one of a group of contiguous claims to wit:

The discovery work for the benefit of ~~the entire group was done in the claim or claims as follows:~~ The claim was done in claim R-40

and consisted of: a drill hole, 110 feet deep, located about 250 feet, S 35° E from the discovery monument,

Beginning at the NE corner a 4-inch by 4-inch by 4½ foot wooden post set in a mound of earth or stones 2 feet in height by 4 feet in diameter and marked "NE Cor. R-40"; thence W (name of claim) 750 feet to the N side center post, a post of the same dimensions as that mentioned above surrounded by a mound of earth and stones as above described and marked "N Side Center R-40", (name of claim) thence W 750 feet to the NW corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "NW Cor. R-40", (name of claim) thence S 600 feet to the SW corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "SW Cor. R-40", (name of claim) thence E 750 feet to the S side center post, a post of the same dimensions surrounded by earth and stones as above set forth and marked "S Side Center R-40", (name of claim) thence 750 feet E to the SE corner of the claim a post of the same dimensions surrounded by earth and stones as set forth and marked "SE Cor. R-40", (name of claim) thence 600 feet N to the point of beginning.

All location work necessary to complete this location had been performed prior to Oct. 13, 1967.

The location work on the group of claims hereinbefore referred to cost at least \$ 100.00.
