
The undersigned hereby certifies that he has located the DEL NO. 58 Mining Claim in the unknown Mining District, in Eureka County, in the State of Nevada, on the 23rd day of August, 1967, at 10:30 a.m.

The length of the claim is 1500 feet, and 1432 feet is claimed in a westerly direction, and 68 feet in an easterly direction from the discovery monument, at which the notice of location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the east to the west.






