

# Amended Location Certificate.

hereby certifies:

That on the 6th day of SEPTEMBER A. D. 1963 ALLEN RUSSELL

discovered within the limits of the VICTORY

Mining Claim, as hereinafter described, a lode of rock in place, bearing gold, silver, copper and other valuable minerals, and thereupon, on said day located the same as a lode Mining Claim by defining the boundaries thereof in the manner prescribed by law, and by posting at the point of said discovery a notice of said location, purporting to comply with the laws of the United States and of the State of Nevada;

That thereafter and within 90 days of the date of posting the original notice of location upon said claim, to-wit, on the 24th day of OCTOBER A. D. 1963, said locator filed a location certificate of said claim with the Recorder of ~~White Pine~~ EUREKA County, Nevada, said certificate being of record in Book 8 Page 245 of Record of Mining Locations of said County, to which record, reference is hereby made;

That the said LOCATOR, ALLEN RUSSELL

IS the owner of said mining claim;

That for the purpose of correcting any and all defects and errors in said original location certificate, and any failure to comply with the requirements of the law before filing the same, and for the purpose of changing the surface boundaries of said claim, and of taking in any and all parts of any and all overlapping claims which have been abandoned, and for the purpose of securing any other and further benefit which may be thereby obtained.

do hereby make and file for record in the office of said recorder, this amended and additional certificate of location of said claim;

That the name of said lode and claim is and it shall be the VICTORY

That the general course of said lode, as nearly as can be ascertained at this time, is WESTERLY and EASTERLY, and the said LOCATOR

claim S. in length along the course of said lode 750 linear feet N. 74 13'30" E. and 750 linear feet S. 74 13'30" W. from the point of discovery, with a width of 300 feet on each side of the center of the vein;

That this amended location embraces said original discovery and also all development and assessment work which has been performed upon or for the benefit of said original claim, and said LOCATOR

by making this amended location, do not abandon any rights which he may have under said original location, but claim that this amended certificate of location relates back to the date of said original location and that HE IS entitled to the benefits of the original discovery and also of all work done and improvements made upon or for the benefit of said original claim;

That the said claim is situated in the CORTEZ Mining District EUREKA or/ LANDER

County, Nevada, and the following is a more particular description of said claim and of each corner thereof as the same is marked upon the ground:

That at each corner and side center, a post at least 4-1-2 feet long and 4 inches square, is set into the ground, and surrounded by a mound of EARTH AND ROCK

That each of said posts is marked as follows to wit:

- the NORTHWEST corner post is marked NW COR VICTORY
- the NORTH side center post is marked NSC VICTORY
- the NORTHEAST corner post is marked NE COR VICTORY
- the SOUTHEAST corner post is marked SE COR VICTORY
- the SOUTH side center post is marked SSC VICTORY
- the SOUTHWEST corner post is marked SW COR VICTORY

That a discovery 100 feet long 10 feet wide and 8 feet deep (from the lowest part of the rim thereof) was, within 90 days of the date of said original location, excavated upon said claim and shows a lode deposit of mineral in place and is located S. 28 34' N., 210 FT.
