LOCATION CERTIFICATE

THIS IS TO CERTIFY that the R-108 lode mining claim was located by Homestake Mining Company, whose present address is 650 California Street, San Francisco, California 94108, on the 28 day of August, 1967.

The general course of said vein or lode as near as it may be described is easterly and westerly.
