LOCATION CERTIFICATE

THIS IS TO CERTIFY that the R-19 lode mining claim was located by Homestake Mining Company, whose present address is 650 California Street, San Francisco, California 94108, on the 29 day of August, 1967.

The general course of said vein or lode as near as it may be described is easterly and westerly. The claim is situated in Cortez Mining District in Eureka County, State of Nevada, and the discovery monument is located approximately 18 miles in a Southeasterly direction from Mount Tenabo. The undersigned claims 20 feet in an easterly direction, and 480 feet in a westerly direction from the point of discovery, with a width of 300 feet on each side of the center of the lode or vein along the entire length of the claim.

Cor. R-1/9"; thence southerly 600 feet to the southeast corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "S.E. Cor. R-1/9"; thence westerly 750 feet to the south side center post, a post of the same dimensions surrounded by earth and stones as above set forth and marked "S Side Center R-1/9"; thence 750 feet westerly to the southwest corner of the claim a post of the same dimensions surrounded by earth and stones as set forth and marked "S.W.
