## LOCATION CERTIFICATE

THIS IS TO CERTIFY that the R-/2/ lode mining claim was located by Homestake Mining Company, whose present address is 650 California Street, San Francisco, California 94108, on the <a href="#x9">49</a> day of August, 1967.

The general course of said vein or lode as near as it may be described is easterly and westerly.
