CERTIFICATE OF LOCATION OF LODE CLAIM

THIS IS TO CERTIFY that the MUF 1 Lode Mining Claim was located by Wm. L. Wilson on the 4th day of September, 1967. The general course of said vein or lode is northwesterly and southeasterly. The claim is situate in the Cortez (unorganized) Mining District, Eureka County, Nevada.
