

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

THIS IS TO CERTIFY that the CM 24A Lode Mining Claim was located by Cortez Metals Co., whose post office address appears below, on the 28th day of September, 1967.

The general course of said vein or lode is easterly and westerly. The claim is situate in the Cortez Mining District, Lander and/or Eureka Counties, Nevada. The NW Corner of this claim is approximately 8,438 feet S 80° E from the SW Corner of Section 6, T. 26 N., R. 48 E., MDB&M.

The Locator claims 225 feet in a westerly direction and 375 feet in an easterly direction from the point of discovery, with a width of 200 feet on each side of the center of the vein or lode along the entire length of said claim. This claim is 300 feet wide by 600 feet long.

The dimensions and location of the discovery work done on the claim are as follows: A bulldozer cut was dug approximately 100 feet N 22° W of the South Side Center of this claim, which cut is approximately 40 feet wide, 100 feet long and averages approximately 5 feet deep. The total cost of such excavation work was in excess of \$100.00.

The corners and side centers of this claim are located and marked as follows: From the SW Corner, a monument marked SW COR CM 24A; thence in a northerly direction 300 feet to the NW Corner, a monument marked NW COR CM 24A; thence in an easterly direction 300 feet to the N. Side Center, a monument marked N. SIDE CTR. CM 24A; thence in an easterly direction 300 feet to the NE Corner, a monument marked NE COR CM 24A; thence in a southerly direction 300 feet to the SE Corner, a monument marked SE COR CM 24A; thence in a westerly direction 300 feet to the S. Side Center, a monument marked S. SIDE CTR. CM 24A; thence in a westerly direction 300 feet to the point of beginning.

Each of the above-described monuments is a 4" by 4" post, 4½ feet long, set one foot of its length in the ground. Markings are on metal tags affixed to said posts.

All location and discovery work necessary to complete this location had been performed by December 23, 1967.
