Said labor was performed during the period between September 1, 1967, and December 1, 1967.

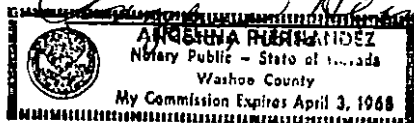
