NOTICE OF LOCATION

NOTICE IS HEREBY GIVEN, that the undersigned located and now claim Fifteen Hundred (1500) feet in length along this vein or lode containing valuable minerals, together with Three Hundred (300) feet in width on each side of the middle of said vein at the surface, and all veins, lodes, mineral and surface ground within the lines of this claim, the general course of said vein or lode running 1420 feet easterly and 10 feet westerly from the discovery monument on which this claim is posted. This claim is in the Mineral Hill Mining District, Eureka, County, State of Nevada, situated

DIAGRAM OF CLAIM—The location (discovery point) and corner monuments should be designated on the accompanying diagram to make the Record of claim more perfect.


A mining claim must not exceed 1500 feet in length along the vein or lode, by 600 feet in width, 300 feet on each side of center of vein at surface.
