

NOTICE OF LOCATION

NOTICE IS HEREBY GIVEN, that the undersigned located and now claim Fifteen Hundred (1500) feet in length along this vein or lode containing valuable minerals, together with Three Hundred (300) feet in width on each side of the middle of said vein at the surface, and all veins, lodes, mineral and surface ground within the lines of this claim, the general course of said vein or lode running 1490 feet easterly and 10 feet westerly from the discovery monument on which this claim is posted. This claim is in the Mineral Hill Mining District, Eureka County, State of Nevada situated

E. corner monument No. 3; thence SOUTH 1500 feet to S. W. corner monument No. 4; thence WEST 300 feet to place of beginning; including all dips, spurs, angles and variations
