NOTICE IS HEREBY GIVEN, that the undersigned located and now claim Fifteen Hundred (1500) feet in length along this vein or lode containing valuable minerals together with Three Hundred (300) feet in width on each side of the middle of said vein at the surface, and all veins, lodes, mineral and surface ground within the lines of this claim, the general course of said vein or lode running 1490 feet

†DIAGRAM OF CLAIM—The location (discovery point) and corner monuments should be designated on the accompanying diagram to make the Record of claim more perfect.

No location of a mining claim can be made until the discovery of the vein or lode within the limits of the ground claimed.

The claim must be distinctly marked on the ground, so its boundaries can be readily traced.

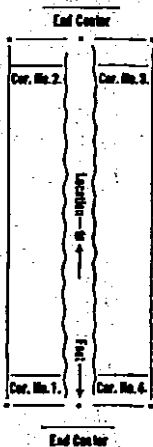
A severe penalty is provided by law for removing or defacing the stakes or monuments of a mining claim.
