## ACKNOWLEDGEMENT

THIS ACKNOWLEDGEMENT made this Sladay of Canada 1968 by HAL T. HALL, a single man, of Grass Valley, California and MILDRED HANCOCK, a single woman, of Reno, Nevada, sometimes hereinafter referred to as assignors, to NEWMONT EXPLORATION LIMITED, a Delaware corporation, authorized to engage in business and hold property in Nevada, sometimes hereinafter referred to as Assignee.
