THIS AGREEMENT, made the 2nd day of February, 1968, by and between MILDRED HANCOCK of Reno, Nevada, and HAL T. HALL of Grass Valley, California, Parties of the First Part, and NEWMONT EXPLORATION LIMITED, a Delaware corporation, Party of the Second Part,

W I T N E S S E T H:

WHEREAS, under date of the 1st day of February, 1967, said Mildred Hancock and Hal T. Hall entered into an assignment with Newmont Exploration Limited, wherein the Parties of the First Part assigned a one-half (1/2) interest in certain claims known as the Blue Star Claims to Newmont Exploration Limited, and

shall have the same effect as if the said description of the Parcel No. 1 Claims in the assignment of the 1st day of February, 1967, had contained the name of said "Blue Star" claim.

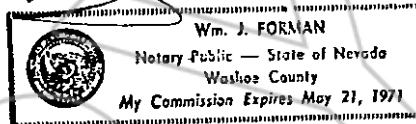

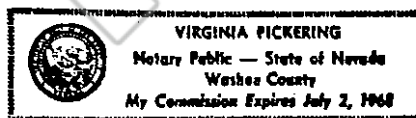

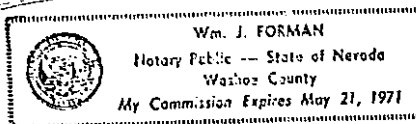
