

ACKNOWLEDGEMENT

THIS ACKNOWLEDGEMENT made this 31st day of January 1968 by TILDA REDWAY and A. JAMES REDWAY, JR., her husband, ELISABETH C. WALKER and CHARLES R. WALKER, III, her husband, sometimes hereinafter referred to as Assignors, to NEWMONT EXPLORATION LIMITED, a Delaware corporation, authorized to engage in business and hold property in Nevada, sometimes hereinafter referred to as Assignee.

W I T N E S S E T H :

WHEREAS, Assignors have, by Agreement entered into February 1, 1967, assigned, transferred and conveyed to Assignee, its successors and assigns, all of Assignors' right, title and interest in and the unpatented lode mining claims located in Section 4, Township 35 North, Range 50 East, Eureka County, Nevada, described as Blue Star, Blue Star No. 1 and Blue Star No. 2 (Parcel No. 1 Claims) and Blue Star, Blue Star Nos. 1 through 20, Blue Star Nos. 24 through 29, and Blue Star Nos. 33 through 35, and all of Assignors' rights, privileges, options and credits under any agreements or other instruments with respect to said claims, all subject, however, to the terms and provisions of the aforesaid Agreement of February 1, 1967; and

respect to the above described claims unless Assignee paid to Assignors on or before then \$65,000; and

WHEREAS, Assignee has fulfilled its obligations under the aforesaid Agreement of February 1, 1967, and is now paying to Assignors the \$65,000;

NOW, THEREFORE, Assignors acknowledge and agree that they have received the SIXTY FIVE THOUSAND DOLLARS (\$65,000) referred to in the aforesaid Agreement of February 1, 1967, and that Assignee has no further obligations under said Agreement (except the warranty and indemnity referred to in Section 3 of said Agreement) and that the assignment contained in the aforesaid Agreement is now absolute and unconditional.
