DECREE SETTLING FIRST AND FINAL ACCOUNT
AND PETITION FOR DISTRIBUTION

HENRY CORTA, Administrator of the above-entitled Estate,
having on the 10th day of April, 1962, rendered and filed herein a
full account and report of his administration of said Estate, which
said account was for a final settlement, and with which said account,
filed a petition for the final distribution of said Estate, and
said account and petition coming on regularly to be heard on the
2nd day of May, 1962, and proof having been made to the satisfaction
of the Court that due and legal notice of the settlement of said
Account and the hearing of said Petition for distribution had been
given as required by law, the Court hereby finds:

That said First and Final Account is in all respects true
and correct;

That due and legal notice to creditors of said Estate
was given in the manner required by law; that no creditor's claims
were filed against said Estate.

1 That all taxes of every name and nature required to be
2 paid by the Decedent's Estate have been paid.

3 That CHARLES B. EVANS, JR., by agreement with the Admin-
4 istrator is to receive a sum as attorney fee of less than 5% of the
5 amount of the appraised value of the Estate as attorney for said
6 Administrator, and that the said attorney did in open Court waive
7 the right to collect said attorney fee from the said Estate.

8 That said Administrator did in open Court waive all of
9 his right to legal commissions and fees due him under the laws of
10 the State of Nevada for acting as Administrator.

11 The Court finds that the following named persons, all of
12 whom are over the age of twenty-one years, are the sole heirs-at-
13 law of the said Decedent:
