WITNESSETH:

That the said party of the first part, in consideration of the sum of TENDOLLARS (\$10.00), lawful money of the United States of America, to it in hand paid by the said part y of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain and sell unto the said part y of the second part, and to his heirs and assigns forever, an undivided one-half interest in and to that certain piece or parcel of land situate in the County of Eureka, State of Nevada, that is described as follows:

FURTHER, RESERVING, THEREFROM, a strip 40' in width along all boundaries for road purposes.

RESERVING, THEREFROM, a right of way, with right of entry upon, over, under, along, across, and through the said land for the purposes of erecting, constructing, operating, repairing and maintaining pole lines with cross arms for the transmission of electrical energy, and for telephone line, and/or for laying, repairing, operating and renewing any pipe line or lines for water, gas or sewerage, and any conduits for electric or telephone wires, and roserving the sole right to convey the rights hereby reserved.
