

# Certificate of Location of Lode Mining Claim

The locator claim 1400 feet in a Northerly direction and 100 feet in a Southerly direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:  
100 feet North of this Discovery Monument a Drill Hole  
100 feet in depth plus a Bulldozer cut 15 feet X 3 ½ ft Deep.

The total cost of such work consisted of at least \$ 100.00

The corners and side centers of the claim are located and marked as follows:

From the southwest corner, a monument marked Southwest SW Cor., thence in a northerly direction 1500 feet to the northwest corner, a monument marked Northwest NW Cor., thence 300 feet in an easterly direction to the north side center, a monument marked North side c NSC, thence 300 feet in an easterly direction to the northeast corner, a monument marked Northeast NE Cor., thence 1500 feet in a southerly direction to the southeast corner, a monument marked Southeast SE Cor., thence 300 feet in a westerly direction to the south side center, a monument marked South side c SSC, thence 300 feet westerly to the point of beginning.

Each of the above-described monuments is a 4 X 4 Post painted White appropriately marked for identification
